#### Art. 9 Reconnaissance

##### Art. 9.1 Registration procedure

Recce cars must be registered with a separate form.

Rally cars used in the event may not be used for reconnaissance.

Each car must be identified with a reconnaissance car number supplied by the organiser. Starting number must be affixed in right upper part of the windscreen.

This identification does ~~not~~ grant an entrance to the service park. ~~Immediately after the reconnaissance these numbers have to be removed from the car.~~

###### ➤ Organisation of special stages

###### Shakedown

- The crew have to be registered for shakedown (see art. 3 SR).
- **The number of passes is limited to 5.**
- Registration fee for the shakedown is 1.000 CZK (40 EUR).
- Only competitors, who passed administrative check and scrutineering, can participate in Shakedown. Competition numbers and advertising stickers must be affixed to their cars. It is compulsory to wear the safety equipment of driver and co-driver as for normal SS.
- For the Shakedown if there is in the car a person, by exception, not rally participant, this person must have an approval from the Clerk of the Course and this person must together with the competitor declare and sign a disclaimer of responsibility – the form will be available at the administrative check and the Shakedown start. ##### 12.4 Special procedures

###### ➤ Service park

###### ➤ Entrance to the Service park in TATRA test area in terms of COVID-19 hygienic arrangements

- Based on arrangements from Hygienic authorities related to COVID-19 each crew is obliged to present at the Administrative checks a list of all team members entering the service area with following details: **name, address, date of birth, phone number and insurance company**
- Persons not presented on the list will not be allowed to enter the service area.
- Number of team personnel (mechanics, staff) is limited to 4 persons
- Number of team personnel (mechanics, staff) for priority drivers can be increased with another 4 persons
- According to actual situation from 3 August 2020 each priority crew can purchase another six labels for entrance, non-priority crew three labels for entrance. The price of the label is 150 CZK.

- All team members (see FIA RRR Art 2.22, with exception for crews) are obliged to be marked with a label, when being inside the TATRA test area. Labels will be provided by the organiser as a part of the entry package.
- **Team member has to be marked with this label already at his first entrance to the Service area.**
- Damaged label will be exchanged for a new one, lost label will not be replaced.
- When asked by the Organizers, people inside the Service area are obliged to prove their rightfulness of their stay in this area with comparing their personal data with provided list of team members.
- Promotional events in the service area are forbidden.
- Hostesses are forbidden.

#### Entrance and parking of the service cars in the service park

- The service park Test area TATRA Kopřivnice may be entered only by cars with sticker SERVICE or AUXILIARY supplied by the organizer (Art. 4.5 SR), **with reconnaissance cars** and by the competition cars. These vehicles can be parked only in the allocated competitor's area.
- Any vehicle without SERVICE or AUXILIARY label found in the service park being parked outside of any team area will be towed away from the service park at the expenses of the owner to the paid parking lot.

#### ROAD CLOSURES

Routes of special stages will be closed for public traffic from following time up to the end of second pass and between the stages will not be re-opened.
